## Release & Hold Harmless Agreement

Every precaution is taken to protect the rider from injury. Rick and/or Daryl DeCarli (stable owners/managers), Nancy Cox, Sarah Towle, Sarah Papale, Bob LaFontaine, & Danielle DeCarli, instructors/trainers at DeCarli Farm LLC, shall not, while exercising reasonable care, be held responsible for any rider's injury.

The following is agreed to in accordance with the Equine Liability Law CGS 52-577. **Assumption of risk by person engaged in recreational equestrian activities when.** Each person engaged in recreational equestrian activities shall assume the risk and legal responsibility of any injury to his person or property arising out of the hazards inherent in equestrian sports, unless the injury was proximately caused by negligence of the person providing the horse or horses to the individual engaged in recreational equestrian activities or the failure to guard or warn against a dangerous condition, use, structure or activity by the person providing the horse or horses or his agents or employees.

All riders must wear ASTM approved safety helmets. All riders must wear boots or sneakers with a heel.

I recognize that there are certain risks inherent in equine activities such as riding, driving, training, horse/pony care, being around or near horses/ponies, and the use of equipment associated with horses/ponies. The risks inherent in these equine activities include, but are not limited to, those dangers presented by the propensity of any horse/pony to run, stop suddenly, shy, kick, bite, buck, stumble, rear, fall, step on, or behave in ways that may result in falls, injury, harm or death to persons around them. Horses/ponies are unpredictable and may react to such things as sounds, sudden movements, other horses/ponies, insects, or unfamiliar objects, persons, or animals. These are some of the risks and dangers the signer acknowledges to be associated with horse activities.

In consideration, therefore, for the privilege or riding, boarding, and/or working around horses/ponies, and the privilege of walking on the property leased by DeCarli Farm LLC and owned by Rick and Daryl DeCarli and extended property owned by Judith Norwood and Irene Gilbert, trustees, of the DeCarli Irrevocable Land Trust, the undersigned does hereby agree to fully release and hold harmless DeCarli Farm LLC, Rick and Daryl DeCarli, DeCarli Irrevocable Land Trust, and Nancy Cox, Danielle DeCarli, Sarah Towle, Sarah Papale, Bev Sadler, & Bob LaFontaine, and further release them from any liability or responsibility for accident damage, injury, or illness to the undersigned resulting from any activity on the premises or to any horse/pony owned by the undersigned or to any family member or persons accompanying the undersigned on the premises. This is in compliance with the CT Equine Inherent Risk Law CGS 52-577.
